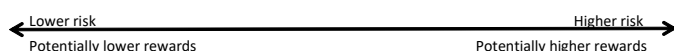
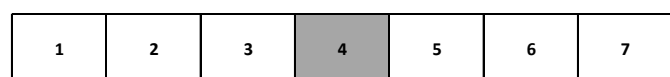

Objectives and investment policy

- * The Sub-Fund aims to provide capital appreciation over the long term.
- * The Sub-Fund invests at least 85 % in Universal Invest Medium (a sub-fund of Universal Invest which is investing maximum 60% in shares of companies, details can be found on www.cadelux.lu). The Sub-Fund may also invest up to 15% directly in shares, cash, cash equivalents and short term bank deposits.
- * The Fund may use financial instruments (“derivatives”) whose value depends on the future prices of other assets. Derivatives are usually used to hedge risk and/or to manage the Sub-Fund more efficiently.
- * On demand, you may buy and sell your shares in the Sub-Fund on each business day in Luxembourg (as defined in the prospectus of the Fund).
- * Share class O accumulation will not distribute any dividend.
- * Share class O distribution aims to distribute a dividend
- * Recommendation : the Sub-Fund may not be appropriate for investors who plan to withdraw their money within 4 years.

Risk and reward profile

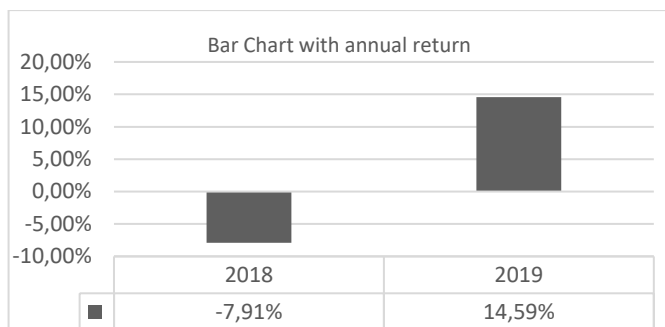
Charges
